**DECLARATION OF ANTHONY PARRIS**

I, Anthony Parris, hereby declare as follows:

1. I am over the age of eighteen and competent to sign this Declaration. I submit this Declaration in support of Defendant Mazda Motor of America, Inc. d/b/a Mazda North American Operations (“MNAO”)’s response to the Objections of Francis J. Farina.

2. I am the Service Manager at Lake Norman Auto Mall, LLC d/b/a Keffer Mazda (“Keffer Mazda”). Based on my prior and current job responsibilities and my review of Keffer Mazda’s business documents and records kept in the ordinary course of business, I am familiar with the information discussed in this declaration, in particular, the information discussing the purchase and maintenance history of a vehicle owned by Francis J. Farina (“Farina”) and the requirements for emissions inspections in North Carolina.

3. Except as to those matters stated upon information and belief—for which matters I have a good faith basis to believe are true and correct—I make this declaration based on my review of corporate documents and records kept in the ordinary course of business, including information obtained by other Keffer Mazda personnel in the course of their duties. If called as a witness, I could and would testify competently as to the matters set forth in this Declaration.

4. I have been informed that Farina is the plaintiff in a proposed class action currently pending in the Western District of North Carolina, *Farina v. Mazda Motor of America, Inc. et al.*, No. 3:23-cv-50 (the “Farina action”). I have been informed that Farina is the owner of the vehicle with the VIN ending in \*\*\*\*\*05719 (the “Vehicle”). Attached as **Exhibit 1** to this Declaration are the true and correct Keffer Mazda purchase records associated with Farina and Farina’s Vehicle. Attached as **Exhibit 2** are true and correct Keffer Mazda repair and maintenance records associated with Farina and Farina’s vehicle (collectively, the “Vehicle Repair and

1 Maintenance Records”). These records are kept in the ordinary course of Keffer  
2 Mazda’s business.

3 5. In April 2021, Farina purchased the Vehicle from Keffer Mazda. (Ex. 1,  
4 at 1.) Since then, he has brought the Vehicle to Keffer Mazda for repair and  
5 maintenance on eight (8) occasions. (*See generally* Ex. 2.)

6 6. Until December 19, 2023, the Repair and Maintenance Records do not  
7 show any complaint of excessive oil consumption. On December 19, 2023, ten  
8 months after Farina filed his lawsuit, Farina brought the Vehicle to Keffer Mazda for  
9 routine maintenance and complained that the “engine ha[d been] burning oil” and was  
10 “down a quart.” (Ex. 2, at 15.) I have been informed that, in response to this complaint,  
11 Keffer Mazda personnel ran a diagnostic test that did not return any codes—in other  
12 words, nothing supporting excessive oil consumption. Because of this, the Keffer  
13 Mazda personnel replaced the Vehicle’s oil and filter and asked Farina to return with  
14 the Vehicle after one month so Keffer Mazda could confirm the oil consumption.  
15 Farina did not return with the Vehicle after one month.

16 7. The next time Farina brought the Vehicle to Keffer Mazda was on April  
17 23, 2024. On that date, Farina requested that a North Carolina Safety and Emissions  
18 Inspection be performed on his vehicle. The results of that Emissions test are found  
19 at page 20 of Exhibit 2. Farina’s Vehicle **passed the North Carolina emissions**  
20 **inspection in full.**

21 8. In particular, the North Carolina emissions inspection process involves  
22 two parts. First, a “certified analyzer” is connected to the vehicle’s second-generation  
23 “on-board diagnostic” (“OBDII”) system to ensure that all vehicle emissions  
24 components/systems are working per the manufacturer’s specifications (the “OBDII  
25 Test”). The OBDII system and test allows the inspector to detect any problems with  
26 the vehicle’s emissions components that could result in lack of performance, high  
27 emissions, or poor fuel economy. Second, a visual safety and tampering inspection is  
28 conducted on the vehicle’s emissions components (the “Tampering Inspection”).



9. Farina’s vehicle passed all applicable components of both the Tampering Inspection and the OBDII Test.

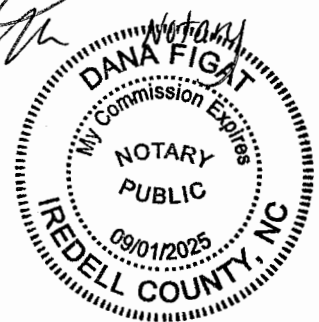
10. Based on review of repair and related records at Keffer, Farina’s request for an emissions inspection in April 2024 was the first and only emissions-related request Farina made to Keffer regarding the Vehicle. Farina has never complained to Keffer or brought the Vehicle in for service or repair of any issue emissions components or complained the Vehicle’s emissions or emissions-component do not comply with the Vehicle’s emissions requirements or warranties.

I declare under penalty of perjury under the laws of the United States of America that the foregoing is true and correct.
