DECLARATION OF JAHMY S. GRAHAM

I, Jahmy S. Graham, hereby declare as follows:

1. I am an attorney at law, duly licensed to practice in the State of California and before this Court, and I am a partner with Nelson Mullins Riley & Scarborough LLP, attorneys of record for Defendant Mazda Motor of America, Inc. d/b/a Mazda North American Operations ("MNAO"). I make this declaration based on personal knowledge of the facts set forth herein, except for those matters stated on information and belief, which I believe to be true and have a good faith basis for that belief. If called as a witness, I could and would testify competently as to the matters set forth in this Declaration. I submit this Declaration in support of MNAO's Response to Objections and in Support of the Proposed Class Settlement.

2. Attached as **Exhibit 1** to this Declaration is a true and correct copy of the Declaration of Bronyn Heubach, Director at JND Legal Administration ("JND").

3. Attached as **Exhibit 2** to this Declaration are true and correct copies of MNAO's complete Warranty History and Customer Pay History for the vehicle associated with the VIN ending in 605719, the vehicle of objector Francis J. Farina ("Farina's Vehicle").

4. Attached as **Exhibit 3** to this Declaration is a true and correct copy of a Carfax report on Farina's Vehicle. The Carfax report includes information available as of July 22, 2024.

5. Attached as **Exhibit 4** to this Declaration are the repair and maintenance records that Lake Norman Auto Mall, LLC d/b/a Keffer Mazda ("Keffer")¹ provided to MNAO for Objector Francis J. Farina's Vehicle. The records are current through December 2024. MNAO has not obtained the Keffer's repair and maintenance records for the period covering January 2024 through July 2024.

6. Based on these available records, it appears Farina has never presented his vehicle for a repair of an emissions component and his vehicle has not registered a failed emissions test. Based on the records available to MNAO, Farina has never had the valve stem seal repair completed.

7. Attached as **Exhibit 5** is a true and correct copy of the "Consolidated Financial Results" of Mazda Motor Corporation ("Mazda") for the period covering April 1, 2022 through June 30, 2022. This document is publicly available on Mazda's website.² This document shows that Mazda, MNAO's parent company, was recording a non-current liability called "Provision related to environmental regulations" during the period covering April 1, 2022 through June 30, 2022, before Farina filed his North Carolina action in January 2023. **Ex. 5** at 5.

The parties have reached a settlement to avoid the costs of litigation, and provide class members relief, repair, a warranty extension and compensation for qualifying past oil refills or oil changes.

Who is affected? You will be bound by the terms of the Settlement, you will obtain the extended warranty coverage to your vehicle, and you can get the Valve Stem Seal repair now. You will not receive any reimbursement for past qualifying expenses unless you submit a claim. By doing nothing you do give up certain rights to sue Mazda or other Released Persons or Entities. Exclude yourself. If you ask to be excluded, you will not get any settlement benefits and you cannot object to the Settlement. 

Financial performance on a consolidated basis for the first three months of the fiscal year ending March 31, 2023 was as follows. Net sales amounted to \$617.2 billion, a decrease of \$186.2 billion or 23.2 % compared to the corresponding period in the previous fiscal year. Operating loss amounted to \$19.5 billion. (For the first three months of the previous fiscal year, operating income was \$26.1 billion.) As of June 30, 2022, total assets increased \$128.2 billion from the end of the previous fiscal year, to \$3,096.4 billion. Total liabilities increased \$89.9 billion from the end of the previous fiscal year to \$1,741.3 billion.

Net Assets as of June 30, 2022 increased ¥38.4 billion from the end of the previous fiscal year to ¥1,355.1 billion, reflecting net income attributable to owners of the parent ¥15.0 billion and increase in Accumulated Other

Cash and cash equivalent as of June 30, 2022 decreased ¥6.2 billion from the end of the previous fiscal year to ¥734.2 billion. Interest-bearing debt as of June 30, 2022 increased ¥132.0 billion from the end of previous fiscal year to ¥812.8 billion. As a result, after subtracting cash and cash equivalents from the interest-bearing debt, net interest-bearing debt amounted to ¥78.6 billion.

Cash flows for the first three months of the fiscal year ending March 31, 2023 by activities were as follows.

Cash flows from operating activities

Net cash used in operating activities was \$132.5 billion, reflecting an increase in inventories, etc. partially offset by income before income taxes of \$20.3 billion. (For the first three months of the previous fiscal year, net cash provided by operating activities was \$22.3 billion.)

Cash flows from investing activities

Net cash used in investing activities was ¥32.3 billion, mainly reflecting capital expenditure for the purchase of property, plant and equipment of ¥28.4 billion. (For the first three months of the previous fiscal year, net cash used in investing activities was ¥33.5 billion.)

As a result, consolidated free cash flow (net of operating and investing activities) was negative \$164.7 billion. (For the previous fiscal year, consolidated free cash flow was negative \$11.2 billion.)

Cash flows from financing activities

Net cash provided by financing activities was ¥112.4 billion mainly due to the increase in short-term loans. (For the first three months of the previous fiscal year, net cash provided by financing activities was ¥108.3 billion.)

(3) Future Estimates such as Consolidated Financial Forecast

The full-year forecast of fiscal year ending March 31, 2023 remains unchanged from the previous forecast, released on May 13, 2022.
